### 4. First-aid measures

<b>Inhalation</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a physician or poison control center immediately.

**Methods and materials for containment and cleaning up**

Prevent entry into waterways, sewer, basements or confined areas.
